CITY COUNCIL REGULAR MEETING

JANUARY 17, 2023

The City Council of the City of McKinney, Texas met in regular session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas, on Tuesday, January 17, 2023, at 6:00 p.m.

The meeting was broadcast live on cable television Spectrum Channel 16 and AT&T U-Verse Channel 99; and online at http://mckinneytx.new.swagit.com/views/130. A video recording of the meeting is available to the public through the City of McKinney meeting archive.

Mayor George C. Fuller called the meeting to order at 6:01 p.m. upon determining a quorum consisting of himself and the following members were present: Mayor Pro Tem Rainey Rogers, and Council Members Justin Beller, Geré Feltus, Rick Franklin, Charlie Philips, and Patrick Cloutier.

Council Member Cloutier expressed comfort with approving the item only if a Sprouts grocery store were built at the location. Director Arnold stated such a requirement could not be tied to the approval, though Mr. Woodruff went on record committing that with approval of the preliminary plat, a Sprouts grocery store would indeed be built at the location.

Council unanimously approved the motion by Council Member Philips, seconded by Council Member Franklin, to approve the preliminary plat with conditions as provided in the staff report, and with a variance from Section 2.9.A.3 of the Engineering Design Manual for Traffic Signal Spacing as requested by the applicant.

Mayor Fuller called for Council and Manager Comments relating to various items of public interest.

Mayor Pro Tem Rogers commended and thanked the Boys Scouts in the audience for attending the City Council meeting. Mayor Fuller thanked them for leading the Pledge of Allegiance.

Council Member Cloutier acknowledged city staff Joe Mazzola, Jimmy Thomas and Empress Drane for a recent panel discussion about Dr. Martin Luther King, Jr. which Council Members Cloutier and Feltus attended. Council Member Cloutier emphasized Dr. King's remarks about the "tranquilizing drug of gradualism" and the inspirational things he accomplished in his short life. Council Member Cloutier also encouraged the public to support the McKinney Parks Foundation on Thursday January 19 at Stix Ice House. Parks Foundation members will be in attendance from 6:30 to 8:30 p.m. and fifteen (15) percent of sales will be donated to the Foundation.

Council Member Feltus commended the city staff regarding the MLK Jr. discussion; commended the Collin County MLK Appreciation Day Committee, Beth Bentley and the other members for their dinner event, discussion on MLK, and Mary Alice Garza for winning the Drum Major Award; commended St. James CME Church for their MLK Service which featured youth singers and remarks by Dr. Jeremy Williams who is a Pastor in Plano, Texas.

City Manager Paul Grimes thanked city staff Gary Graham, Thuan Huynh and their team for work on the agenda item # 22-0256PP development project, acknowledging its challenges; and emphasized the value of trust regarding the work of the city organization, the importance of positive relationships among staff, the community and City Council, and the contrasting roles of staff and City Council in making city decisions. City Manager Grimes announced the Parks & Recreation department and the McKinney Public Libraries have released their respective Spring Activity guides both of which are available online at https://www.mckinneytexas.org.

Mayor Fuller announced a benefit event for Fireman Jack Piontkowsky will be held on January 28 at the Sanctuary who was seriously injured over the holidays. The "Leave Your Hat On" event is sold out and will include raffles, auction items and live music performances by Buffalo Ruckus and Maylee Thomas.

Mayor Fuller called for a motion to adjourn at which time the Council approved the motion by Mayor Pro Tem Rogers, seconded by Council Member Feltus to adjourn the meeting at 7:57 p.m.
