Q6 Which mode(s) of transportation do you primarily use to cross S.H. 5/McDonald?





Q7 How safe/comfortable do you feel as a bicyclist crossing a multi-lane divided roadway at a signalized intersection?





Q8 How safe/comfortable do you feel as a pedestrian crossing a multi-lane divided roadway at a signalized intersection?





Q9 Would any of the options presented encourage you to cross S.H. 5 on foot/walking or by bicycle?






Q10 In your opinion, is there a need for more public space and amenities in this Historic Downtown McKinney Cultural District (i.e. parks, gathering/event space, etc.)




