Dear Council Member Feltus,

I am sending you this in advance of your May 23 meeting on this important agenda item.

The long-term commercial success of downtown depends on one thing – VISITORS. Without that nothing else matters. The goal of the City Council in this redevelopment should be “how to maximize the asset of McKinney’s Cultural District.” If the Council can do this, the heightened reputation that will come to the city will only be exceeded by the economic benefit it brings.

The worst thing the Council could do is sacrifice these properties to developers who want to erect visitor-killing residential blocks. Housing is important to the overall health of a city, but the more housing there is in this limited area of our downtown, the fewer reasons there will be for people to visit. The FUTURE of McKinney depends on getting this redevelopment right.

Because a vibrant downtown is a place where people want to SHOP, find ENTERTAINMENT, DINE, and GATHER, it is important for the Council to be imaginatively ambitious in its urban planning and build on McKinney’s reputation as a desirable destination choice. Great cities offer performance halls, downtown parks, museums, event centers, pedestrian boulevards, and cultural centers complemented with unique private sector retail and restaurants. In short, great downtowns have lots to experience.

A RECOMMENDATION

The success of the downtown redevelopment can be enhanced if the 5-block (four lot) development is thought of as a whole with a unifying purpose or theme. With this in mind, I would like to submit a proposal for your consideration.

The theme of this development is based on images and promotions that the City has already used – BUTTERFLIES. The two blocks just east of the Hall Library would be a green space dedicated to butterflies and hummingbirds that pass through McKinney on their annual migration. These two blocks are to be landscaped with pollinator plants and the metal butterfly sculptures that appear around town could all be relocated here to Butterfly Park. It would be a park for education, relaxation, and celebration.

Butterfly Park would provide a needed alternative location for downtown festivals. There would no longer be the need to disturb commerce on the Square with street closures. The park could be the new home to Arts 'n Bloom, Dia de los Muertos, Oktoberfest, Home for the Holidays and allow even more festivals during the year. Its unique purpose and location would become iconic and likely to attract even more tourists and photographers than butterflies.

Next to Butterfly Park would be the McKinney Opera House, a performance hall that would feature nationally-known musicians and performers. This venue, more upscale than our current MPAC, borrows its name from the historic hall that entertained area residents over a century ago. Other structures on the remaining blocks would include a parking garage and a retail/office block (or hotel/event center).

The attached image provides context and greater clarity about how this complex could be laid out. I provide this to you for your consideration and hope it inspires you to think of this redevelopment in terms of what is possible and beneficial for the long-term desirability and success of our town. This redevelopment will determine the future of downtown McKinney. It will be what McKinney is known for. Let's spend the time and effort to get this right.
