

**RESOLUTION NO. 2023-05-XXX (R)**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AN AGREEMENT WITH BALCONES RECYCLING, INC. FOR RECYCLING PROCESSING SERVICES AND FRONTIER TEXAS VENTURES I, LLC dba FRONTIER WASTE SOLUTIONS FOR THE COLLECTION OF SOLID WASTE AND RECYCLING**

**WHEREAS,** the City Council of the City of McKinney, Texas seeks to award contracts for solid waste and recycling collection and recycling processing services;

**WHEREAS,** the City issued solicitation 23-11RFP Solid Waste & Recycling Collection and Recycling Processing Services and has received proposals from six firms out of 114 supplier notifications;

**WHEREAS,** the proposals were received and reviewed by Procurement Services and the City's consultant, Burns & McDonnell, for responsiveness and whether the contents complied with the terms and conditions of the RFP, and then reviewed and scored by the Evaluation Committee;

**WHEREAS,** the Evaluation Committee is recommending based on combined scoring results, the City move forward with exclusive negotiations for with Frontier Waste Solutions for collection services and with Balcones Recycling, Inc. for recycling processing; and

**WHEREAS,** the current solid waste and recycling collection and processing services contract expires September 30, 2024, and timely execution of the next solid waste and recycling collection and recycling processing services agreements for the City is important to meeting the timeline.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:**

- Section 1. The City Council of the City of McKinney, Texas hereby authorizes the City Manager to negotiate an agreement with Balcones Recycling, Inc. for recycling processing services and with Frontier Waste Solutions for the collection of solid waste and recycling.
- Section 2. The period of exclusive negotiations between the City of McKinney and Balcones Recycling, Inc. and Frontier Waste Solutions shall continue in effect through August 15, 2023, unless further authorized by the City Council.
- Section 3. In the event negotiations are unsuccessful with either firm in the period described in Section 2, the City Manager is authorized to commence like negotiations for the same purposes in Section 1 with the next highest scoring respondent to Request for Proposal (RFP), 23-11RFP for Solid Waste & Recycling Collection and Recycling Processing Services.
- Section 4. Any contemplated final agreement between the City and Balcones Recycling, Inc. and Frontier Waste Solutions (or any other respondent) shall be considered for approval by the City Council at a regular public meeting.
- Section 5. This Resolution shall take effect immediately from and after the date of passage and is so resolved.
