

## LEGAL DESCRIPTION

BEING a 4.703 acre tract of land situated in the H. Chenaweth Survey, Abstract Number 157, located in the City of McKinney, Collin County, Texas, being called a 4.704 acre tract of land described as "Tract 1" in a General Warranty Deed (drafted without benefit of title examination or title insurance) to Billy Charles Brown recorded in Instrument Number 20170206000165180, Official Public Records, Collin County, Texas, (OPRCCT), said 4.703 acre tract and being described as follows:

**BEGINNING** at a found 1/2" iron rod at the northeast corner of said Tract 1, on the west right-of-way line of F.M. Highway 1827 (90' wide) and the southeast corner of a called 34.101 acre tract of land in a General Warranty Deed with Vendor's Lein to McKinney Hill Park, LLC recorded Instrument Number 20170111000044550, OPRCCT and a Correction Instrument recorded in Instrument Number 20170221000229560, OPRCCT, from which a found 1/2" iron pipe bears North 41 degrees 04 minutes East, a distance of 0.4 feet;

**THENCE** South 35 degrees 48 minutes 22 seconds West, with the east line of said Tract 1 and the west right-of-way line of said F.M. Highway 1827, a distance of 301.78 feet to a found concrete monument at the eastern most southeast corner of said Tract 1 and an angle point on the west right-of-way line of said F.M. 1827;

**THENCE** South 71 degrees 29 minutes 51 seconds West, continuing with the east line of said Tract 1 and the west right-of-way line of said F.M. Highway 1827, a distance of 81.28 feet to a found monument at the southern most southeast corner of said Tract 1, being on the north right-of-way line of U.S Highway 380 (variable width);

THENCE North 73 degrees 10 minutes 01 seconds West, with the south line of said Tract 1 and the north right-of-way line of said U.S. Highway 380, a distance of 227.15 feet to a found 1/2" iron rod with cap stamped "ypassociates.com" at an angle point on the south line of said Tract 1 and the north right-of-way line of said U.S. Highway 380;


THENCE North 61 degrees 51 minutes 43 seconds West, continuing the south line of said Tract 1 and the North right-of-way line of said U.S. Highway 380, a distance of 102.42 feet to a found iron rod with cap stamped "TXDOT ROW" at an angle point on the south line of said Tract 1 and the north right-of-way line of said U.S. Highway 380;

THENCE North 73 degrees 14 minutes 20 seconds West, continuing with the south line of said Tract 1 and the north right-of-way line of said U.S. Highway 380, a distance of 274.07 feet to a found iron rod with cap stamped "TXDOT ROW" at the southwest corner of said Tract 1;



- South 89 degrees 27 minutes 32 seconds East, a distance of 168.66 feet to a found 1/2" iron rod;
- South 84 degrees 43 minutes 42 seconds East, a distance of 91.23 feet to a found 1/2" iron rod;
- South 52 degrees 21 minutes 48 seconds East, a distance of 64.69 feet to the POINT OF BEGINNING and containing 4.703 acres of land, or 204,873 square feet of land, more or less.
