

HISTORIC PRESERVATION ADVISORY BOARD

MARCH 7, 2024

The Historic Preservation Advisory Board of the City of McKinney, Texas met in regular session in the Council Chambers of the Municipal Building on Thursday, March 7, 2024 at 5:30 p.m.

Chairperson Petkovsek called the meeting to order at 5:30 pm upon determining a quorum was present.

There were 9 guests present.

Chairperson Petkovsek called for Public Comments for non-public hearing agenda items. There were no public comments

Chairperson Petkovsek called for consideration of the information sharing items.

24-1285 Informational update on the 2024 Municipal Bonds.

Director of Strategic Services with City Manager's office, Trevor Minyard gave the presentation. The Board posed questions to the presenter regarding planned bond presentations to the public and street improvement clarifications.

Planning Manager Paula Nasta presented the nominees to consider for the 2025 Historic Home Recognition Calendar. The Board independently voted on each home. Said votes were tallied and the top 12 scores were indicated as the homes to consider.

Board unanimously approved the motion by Board Member Pence, seconded by Vice-Chairperson McWilliams, to approve 24-1289 Consider/Discuss/Act on the Selection of 12 houses for the 2025 Preserve Historic McKinney Home Recognition Program Calendar.

Chairperson Petkovsek called for public comments regarding matters not on the agenda. There were no public comments.

Chairperson Petkovsek called for board and manager comments.

Staff member Paula Nasta announced Women's History month and the places and spaces that highlight women in McKinney. For the Love of Cities author will be presenting to city staff as well as the public. Eclipse activities can be found on the library website. Board Member Prior-Robertson thanked staff for the Undertold Stories presentation.

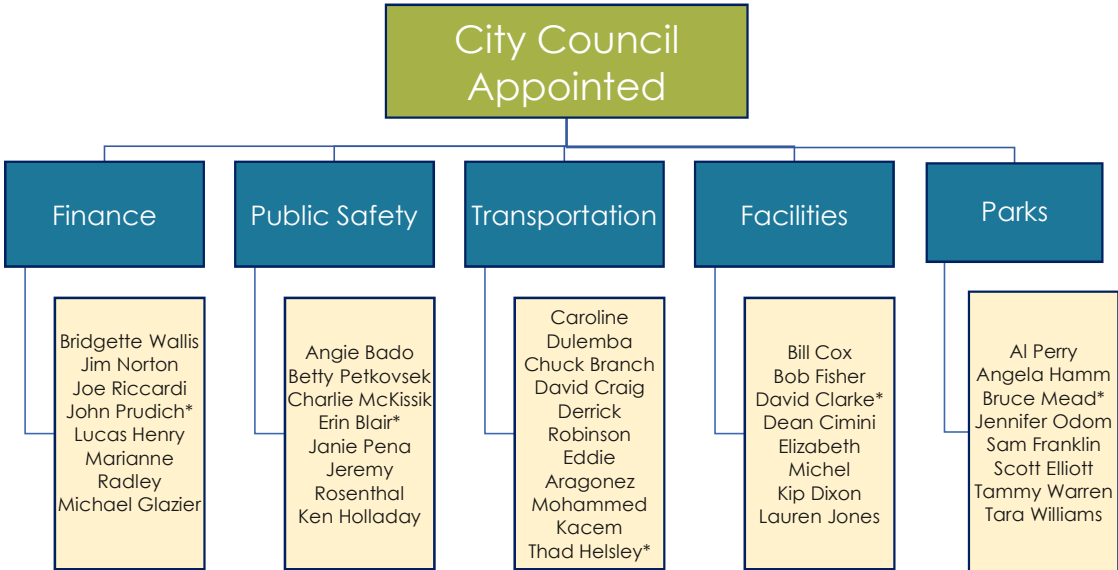
