AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS TO REVISE CHAPTER 62, ENTITLED "MOTOR VEHICLES AND TRAFFIC," OF THE CODE OF ORDINANCES OF MCKINNEY, TEXAS, THROUGH THE AMENDMENT OF ARTICLE V, ENTITLED "SCHOOL ZONES" BY AMENDING SECTION 62 - 218 THROUGH SECTION 62 - 347.2 AS SET FORTH HEREIN BELOW; AMENDING THE CODE OF ORDINANCES, CITY OF MCKINNEY, TEXAS; PROVIDING FOR PUBLICATION OF THE CAPTION OF THE ORDINANCE, EFFECTIVE DATE HEREOF AND A PENALTY CLAUSE

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:

Section 1. The City Council of the City of McKinney, Texas hereby amends Article V. – School Zones to read as follows:

**ARTICLE V. - SCHOOL ZONES**

**Sec. 62-218. - Definitions.**

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Fire lane* means that portion of a public street where only moving vehicles are allowed.

*No parking zone* means a space or area designated by ordinance and clearly marked and posted to prohibit the parking of vehicles.

*School days* means that period of the week from Monday through Friday during regular school terms, during the year, a public announcement of which has been made in a local newspaper.

*School zone* means that public street right-of-way near a school as described in this article. Measurements are referenced from centerline of intersecting roadways.

*Speed limit* means the maximum speed of vehicular traffic within the boundary of the speed zone.

**Sec. 62-219. - Summer school zones.**

- (a) The location and times of the summer school sessions will be determined by each school district and adopted as a summer school zone by the city council by resolution annually. The location and times of summer school zones shall control during summer school session. The annual adoption of locations and hours for summer school zones shall not amend hours and locations as set out in this article for the regular school term.
- (b) In all school zones adopted under this article it shall be unlawful and an offense for any person to drive or operate a motor vehicle in an established school zone at a speed greater than the established school speed limit during summer school sessions.
- (c) In all school zones adopted under this article is shall be unlawful and an offense for any person to park, stop and/or stand a motor vehicle in an established prohibited locations under this article during the summer school sessions.
- (d) All permanent and temporary signage used to enforce the safety provisions adopted under this article during the regular school term shall be applicable during the summer school sessions.

**Sec. 62-220. - McKinney High School—Zone designated.**

The boundaries of the McKinney High School zone shall be:

- (1) On Eastbound Wilson Creek Parkway beginning at a point 215 feet west of Graves Street and extending eastbound along Wilson Creek Parkway to the east property line of McKinney High School.
- (2) On Westbound Wilson Creek Parkway beginning at the east property line of McKinney High School and extending westward along Wilson Creek Parkway to a point 215 feet west of Graves Street.
- (3) On Graves Street beginning at Wilson Creek Parkway and extending northward along Graves Street to the north property line of the McKinney High School.

**Sec. 62-221. - Same—Speed.**

The speed limit for vehicles traveling the streets within the McKinney High School zone during the hours of 6:45 a.m. to 7:45 a.m. and 2:15 p.m. to 3:15 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-222. - Same—U-Turns.**

It shall be unlawful for any person to drive a motor vehicle to make or cause to be made by said vehicle a U-Turn movement during the hours of 6:45 a.m. to 7:45 a.m. and 2:15 p.m. to 3:15 p.m., on school days, at the following locations:

- (1) On Westbound Wilson Creek Parkway at Graves Street

**Sec. 62-223. - McKinney North High School—Zone designated.**

The McKinney North High School zone shall be:

- (1) On Eastbound Wilmeth Road beginning at a point 180 feet east of High Pointe Boulevard and extending eastward along Wilmeth Road to a point 120 feet west of Community Avenue.
- (2) On Westbound Wilmeth Road beginning at a point 120 feet west of Community Avenue and extending westward along Wilmeth Road to a point 180 feet east of High Pointe Boulevard.
- (3) On Community Avenue beginning at a point 130 feet north of Wilmeth Road and extending northward along Community Avenue to a point 1,120 feet south of Brinlee Branch Lane.

**Sec. 62-224. - Same—Speed.**

The speed limit for vehicles traveling the streets within the McKinney North High School zone during the hours of 6:45 a.m. to 7:45 a.m. and 2:15 p.m. to 3:15 p.m., school days, shall be 20 miles per hour maximum

**Sec. 62-225. - Reserved**

**Sec. 62-226. – McKinney Boyd High School—Zone designated.**

The McKinney Boyd High School zone shall be:

- (1) On Northbound Lake Forest Drive beginning at a point 200 feet north of Grampian Way and extending northward along Lake Forest Drive to the north property line of McKinney Boyd High School.
- (2) On Southbound Lake Forest Drive beginning at the north property line of McKinney Boyd High School and extending southward along Lake Forest Drive to a point 200 feet north of Grampian Way.

**Sec. 62-227. - Same—Speed.**

The speed limit for vehicles traveling the streets within the McKinney Boyd High School zone during the hours of 6:45 a.m. to 7:45 a.m. and 2:15 p.m. to 3:15 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-228. - Faubion Middle School—Zone designated.**

The Faubion Middle School zone shall be:

- (1) On Hollis Street beginning at Doe Rollins Street and extending northward along Hollis Street to a point 200 feet north of Camellia Lane.
- (2) On Doe Rollins Street beginning at Hollis Street and extending eastward along Doe Rollins Street to Duvall Street.
- (3) On Duvall Street beginning at a point 240 feet north of Josephine Street extending southward along Duvall Street to Doe Rollins Street.
- (4) On Paula Road beginning at a point 135 feet south of Doe Rollins Street and extending northward along Paula Street to Doe Rollins Street.
- (5) On Isola Road beginning at a point 135 feet south of Doe Rollins Street and extending northward along Isola Road to Doe Rollins Street.

**Sec. 62-229. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Faubion Middle School zone, during the hours of 8:00 a.m. to 9:00 a.m. and 3:30 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-230. - Reserved.**

**Secs. 62-231, 62-232. - Reserved.**

**Sec. 62-233. - Dowell Middle School—Zone designated.**

The Dowell Middle School zone shall be:

- (1) On Northbound Ridge Road beginning at a point 600 feet north of Maize Circle and extending northward along Ridge Road to a point 460 feet south of Virginia Parkway.
- (2) On Southbound Ridge Road beginning at a point 460 feet south of Virginia Parkway and extending southward along Ridge Road to a point 600 feet north of Maize Circle.

**Sec. 62-234. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Dowell Middle School zone during the hours of 8:00 a.m. to 9:00 a.m. and 3:30 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-235. - Reserved.**

**Sec. 62-236. – Scott Johnson Middle School—Zone designated.**

The Scott Johnson Middle School zone shall be:

- (1) On Community Avenue beginning at a point 870 feet south of Brinlee Branch Lane and extending northward along Community Avenue to a point 150 feet south of Brinlee Branch Lane.

**Sec. 62-237. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Scott Johnson Middle School zone, during the hours of 8:00 a.m. to 9:00 a.m. and 3:30 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-237.1. - Same—Crosswalks.**

Crosswalks shall be established at the Scott Johnson Middle School zone as follows:

- (a) At the intersection of Community Avenue and the exit to the front driveway of Scott Johnson Middle School.

**Sec. 62-238. - Evans Middle School—Zone designated.**

The Evans Middle School zone shall be:

- (1) On Eastbound Eldorado Parkway beginning at a point 360 feet west of Hillsdale Drive and extending eastward along Eldorado Parkway to a point 1,085 feet west of Hudson Crossing.
- (2) On Westbound Eldorado Parkway beginning at a point 1,085 feet west of Hudson Crossing and extending westward along Eldorado Parkway to a point 130 feet west of Hillsdale Drive.

**Sec. 62-239. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Evans Middle School zone during the hours of 8:00 a.m. to 9:00 a.m. and 3:30 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-240. – Reserved.**

**Sec. 62-241. - Roach Middle School—Zone designated.**

The Roach Middle School zone shall be:

- (1) On Northbound Independence Parkway beginning at the City boundary line and extending northward along Independence Parkway to a point 300 feet north of George Washington Drive.
- (2) On Southbound Independence Parkway beginning at a point 300 feet north of George Washington Drive and extending southward along Independence Parkway to the City boundary line.

**Sec. 62-242. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Roach Middle School zone during the hours of 7:30 a.m. to 8:30 a.m. and 3:40 p.m. to 4:40 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-243. - Caldwell Elementary School—Zone designated.**

The Caldwell Elementary School zone shall be:

- (1) On Virginia Street beginning at a point 280 feet east of Bradley Street and extending westward along Virginia Street to a point 95 feet west of Bradley Street.
- (2) On Louisiana Street beginning at a point 220 feet west of Bradley Street and extending eastward along Louisiana Street to a point 90 feet east of College Street.
- (3) On Largent Street beginning at a point 140 feet west of Bradley Street extending eastward along Largent Street to Bradley Street.
- (4) On Davis Street beginning at College Street and extending eastward along Davis Street to a point 280 feet east of College Street.
- (5) On Armstrong Street beginning at College Street and extending westward along Armstrong Street to Bradley Street.
- (6) On Bradley Street beginning at a point 130 feet south of Armstrong Street and extending northward along Bradley Street to a point 165 feet north of Virginia Street.
- (7) On College Street beginning at a point 20 feet north of Howell Street and extending northward along College Street to Louisiana Street.

**Sec. 62-244. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Caldwell Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-245. - Same—Bradley Street.**

Bradley Street shall be one-way for vehicular travel from south to north between a point 90 feet north of Armstrong Street and Louisiana Street.

**Sec. 62-246. - Same—Crosswalks.**

Crosswalks shall be established at the Caldwell Elementary School Zone as follows:

- (a) At the intersection of Bradley Street and Virginia Street.
- (b) At the intersection of Bradley Street and Louisiana Street.

**Sec. 62-247. – Reserved**

**Sec. 62-248. - Walker Elementary School—Zone designated.**

The Walker Elementary School zone shall be:

- (1) On Maverick Trail beginning at a point 215 feet west of Orchid Drive and extending northwestward along Maverick Trail to Cockrill Drive.
- (2) On Winding Brook Drive beginning at Cockrill Drive and extending northward along Winding Brook Drive to a point 190 feet north of Lindale Drive.
- (3) On Cockrill Drive beginning at a point 140 feet east of Dalhart Trail and extending eastward along Cockrill Drive to a point 200 feet east of Maverick Trail.
- (4) On Lindale Drive beginning at Winding Brook Drive and extending eastward along Lindale Drive to a point 100 feet east of Winding Brook Drive.

**Sec. 62-249. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Walker Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-250. - Same—Crosswalks.**

Crosswalks shall be established at the Walker Elementary School zone as follows:

- (a) At the intersection of Cockrill Drive and Maverick Trail/ Winding Brook Drive.

**Sec. 62-251. - Wolford Elementary—Zone designated.**

The Wolford Elementary School zone shall be:

- (1) On Hillsdale Drive beginning at Eldorado Parkway and extending northward along Hillsdale Drive to a point 200 feet north of Berkshire Road.
- (2) On Berkshire Road beginning at Hillsdale Drive and extending eastward along Berkshire Road to a point 200 feet east of Waterbrook Drive.

**Sec. 62-252. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Wolford Elementary School zone during the hours of 7:15 a.m. to 9:00 a.m. and 2:45 p.m. to 4:30 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-253. - Same—Crosswalks.**

Crosswalks shall be established at the Wolford Elementary School zone as follows:

- (a) At the intersection of Hillsdale Drive and Berkshire Road.
- (b) At the intersection of Berkshire Road and Waterbrook Drive.

**Sec. 62-254. – Reserved.**

**Sec. 62-255. - Webb Elementary School—Zone designated.**

The Webb Elementary School zone shall be:

- (1) On Greenville Road beginning at eastern Murray Street and extending eastward along Greenville Road to eastern Wilson Street.
- (2) On Jennie Street beginning at Louisiana Street and extending southward along Jennie Street to Greenville Road.
- (3) On Louisiana Street beginning at a point 100 feet east of Murray Street and extending eastward along Louisiana Street to a point 150 feet east of Jennie Street.

**Sec. 62-256. - Same—Speed.**

The speed limit for vehicles traveling the streets within Webb Elementary School zone, during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-257. - Same—Crosswalks.**

Crosswalks shall be established at the Webb Elementary School zone as follows:

- (a) On Greenville Road, approximately 100 feet west of Jennie Street.
- (b) On Louisiana Street, approximately 150 feet west of Jennie Street.

**Sec. 62-258. – Reserved.**

**Sec. 62-259. – Reserved.**

**Sec. 62-260. - Finch Elementary School—Zone designated.**

The Finch Elementary School zone shall be:

- (1) On Tennessee Street beginning at a point 250 feet south of Wilson Creek Parkway and extending northward along Tennessee Street to a point 200 feet north of Graham Street.
- (2) On Graham Street beginning at Tennessee Street and extending eastward along Graham Street to Chestnut Street.
- (3) On Wilson Creek Parkway beginning at a point 250 feet east of Kentucky Street and extending eastward along Wilson Creek Parkway to Tennessee Street.
- (4) On Elm Street beginning at Tennessee Street and extending eastward along Elm Street to a point 100 feet west of Chestnut Street.

**Sec. 62-261. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Finch Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-262. - Same—Crosswalks.**

Crosswalks shall be established at the Finch Elementary School zone as follows:

- (a) At the intersection of Wilson Creek Parkway/ Elm Street and Tennessee Street.

**Secs. 62-263—62-267. - Reserved.**

**Sec. 62-268. - Slaughter Elementary School—Zone designated.**

The Slaughter Elementary School zone shall be:

- (1) On Carlisle Street beginning at a point 130 feet south of Wolford Street and extending northward along Carlisle Street to Wolford Street.
- (2) On Wolford Street beginning at a point 115 feet east of Courtney Lane and extending eastward along Wolford Street to a point 110 feet west of McCarley Place.
- (3) On Dowell Street beginning at Wolford Street and extending northward along Dowell Street to a point 290 feet south of Bois d'Arc Road.
- (4) On Bois d'Arc Road beginning at a point 130 feet east of Jade Lane and extending eastward along Bois d'Arc Road to a point 130 feet east of Community Avenue.

**Sec. 62-269. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Slaughter Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-270. - Same—Crosswalks.**

Crosswalks shall be established at the Slaughter Elementary School zone as follows:

- (a) At the intersection of Dowell Street and Wolford Street.
- (b) At the intersection of Bois d'Arc Road and Dowell Street.

**Sec. 62-271. - Reserved.**

**Sec. 62-272. – Reserved.**

**Sec. 62-273. - Burks Elementary School—Zone designated.**

The Burks Elementary School zone shall be:

- (1) On Graves Street beginning at a point 210 feet north of Hunt Street and extending northward along Graves Street to a point 25 feet south of Bonner Street.
- (2) On Hill Street beginning at a point 230 feet east of Finch Avenue and extending eastward along Hill Street to a point 250 feet east of Graves Street.
- (3) On Virginia Street beginning at a point 200 feet east of Graves Street extending westward along Virginia Street to a point 100 feet west of Graves Street.
- (4) On Louisiana Street beginning at a point 295 feet west of Graves Street and extending eastward along Louisiana Street to a point 100 feet east of Graves Street.

**Sec. 62-274. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Burks Elementary School zone, during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, on school days, shall be 20 miles per hour maximum.

**Sec. 62-275. - Same—Crosswalks.**

Crosswalks shall be established at the Burks Elementary School Zone as follows:

- (a) At the intersection of Graves Street and Virginia Street.
- (b) At the intersection of Graves Street and Louisiana Street.

**Secs. 62-276—62-278. - Reserved.**

**Sec. 62-279. - C.T. Eddins Elementary School—Zone designated.**

The C.T. Eddins Elementary School zone shall be:

- (1) On Peregrine Drive beginning at a point 100 feet north of Aviary Drive and extending northward along Peregrine Drive to a point 140 feet north of Falcon View Drive.
- (2) On Falcon View Drive beginning at a point 100 feet west of Peregrine Drive and extending eastward along Falcon View Drive to Peregrine Drive.
- (3) On Arbor Creek Lane beginning at a point 125 feet west of Peregrine Drive and extending eastward along Arbor Creek Lane to a point 150 feet east of Falcon Crest Drive.
- (4) On North Cotton Ridge Road beginning at a point 65 feet west of Royal Oaks Drive and extending eastward along North Cotton Ridge Road to a point 65 feet east of Old Hickory Lane.

**Sec. 62-280. - Same—Speed.**

The speed limit for vehicles traveling the streets within the C.T. Eddins Elementary School zone, during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-281. - Same—Crosswalk.**

Crosswalks shall be established at the C.T. Eddins Elementary School zone as follows:

- (a) At the intersection of Arbor Creek Lane and Falcon Crest Drive.
- (b) At the intersection of Falcon View Drive and Peregrine Drive.
- (c) At the intersection of North Cotton Ridge Road and Peregrine Drive.

**Sec. 62-282. – Reserved.**

**Sec. 62-283. - Valley Creek Elementary School—Zone designated.**

The Valley Creek Elementary School zone shall be:

- (1) On Valley Creek Trail beginning at Cedarwood Court/ Creek Crossing Drive and extending eastward along Valley Creek Trail to the east property line of Valley Creek Elementary School.
- (2) On Eastbound Eldorado Parkway beginning at a point 300 feet west of Voltaire Boulevard and extending eastward along Eldorado Parkway to a point 120 feet east of Country Club Drive.
- (3) On Westbound Eldorado Parkway beginning at a point 430 feet east of Country Club Drive and extending westward along Eldorado Parkway to a point 50 feet west of Voltaire Boulevard.

**Sec. 62-284. - Same—Speed.**

The speed limit for vehicles traveling the streets in the Valley Creek Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-285. - Same—Crosswalks.**

Crosswalks shall be established at the Valley Creek Elementary School zone as follows:

- (a) On Valley Creek Trail, approximately 45 feet east of the easternmost driveway of Valley Creek Elementary School.

**Sec. 62-288. - Glen Oaks Elementary School—Zone designated.**

The Glen Oaks Elementary School zone shall be:

- (1) On Eastbound Glen Oaks Drive beginning at a point 1,120 feet east of Wildwood Drive and extending eastward along Glen Oaks Drive to a point 215 feet east of Wildflower Drive.
- (2) On Westbound Glen Oaks Drive beginning at a point 215 feet east of Wildflower Drive and extending westward along Glen Oaks Drive to a point 1,120 feet east of Kings Lake Drive.

**Sec. 62-289. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Glen Oaks Elementary School zone, during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-290. - Same—Left turns.**

It shall be unlawful for any person who is the driver of a motor vehicle to make or cause to be made by said vehicle a left-hand turn during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., on school days, at the following locations:

- (1) Easternmost driveway of Glen Oaks Elementary School, southbound at Glen Oaks Drive.
- (2) Westernmost driveway of Glen Oaks Elementary School, southbound at Glen Oaks Drive.

**Sec. 62-291. - Same—Crosswalks.**

Crosswalks shall be established at the Glen Oaks Elementary School zone as follows:

- (a) At the intersection of Glen Oaks Drive and Wildflower Drive.

**Sec. 62-293. – Reserved.**

**Sec. 62-294. – Reuben Johnson Elementary School—Zone designated.**

The Reuben Johnson Elementary School zone shall be:

- (1) On Ash Lane beginning at a point 165 feet south of Cedar Elm Drive and extending northward along Ash Lane to a point 360 feet south of Avery Lane.
- (2) On Cedar Elm Drive beginning at a point 690 feet east of Woodson Drive and extending eastward along Cedar Elm Drive to a point 225 feet east of Ash Lane.
- (3) On Woodson Drive beginning at a point 115 feet south of Vineyard Lane and extending northward along Woodson Drive to a point 50 feet north of Deer Run Drive.
- (4) On Northbound Ridge Road beginning at a point 300 feet south of Sidney Lane and extending northward along Ridge Road to a point 125 feet north of Sidney Lane.
- (5) On Southbound Ridge Road beginning at a point 300 feet north of Sidney Lane and extending southward along Ridge Road to a point 130 feet south of Sidney Lane.

**Sec. 62-295. - Same—Speed.**

The speed limit for vehicles traveling the streets within the Reuben Johnson Elementary School zone during the hours of 7:15 a.m. to 8:15 a.m. and 2:45 p.m. to 3:45 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-296. - Same—Crosswalks.**

Crosswalks shall be established at the Reuben Johnson Elementary School zone as follows:

- (a) At the intersection of Ash Lane and Cedar Elm Drive.
- (b) At the intersection of Cedar Elm Drive and Woodson Drive.

(c) At the intersection of Ridge Road and Sidney Lane.

**Sec. 62-297. - Malvern Elementary School—Zone designated.**

The Malvern Elementary School zone shall be:

- (1) On Eastbound Eldorado Parkway beginning at a point 200 feet south of Park Central Drive and extending northeastward along Eldorado Parkway to a point 60 feet east of Kingsbury Drive.
- (2) On Westbound Eldorado Parkway beginning to a point 60 feet east of Kingsbury Drive and extending southwestward along Eldorado Parkway to a point 200 feet south of Park Central Drive.
- (3) On Park Central Drive beginning at the west property line of Malvern Elementary School and extending eastward along Park Central Drive to Eldorado Parkway.

**Sec. 62-346.2. - Same—Crosswalks.**

Crosswalks shall be established at the Lindsey Elementary School zone as follows:

- (a) At the intersection of Sugar Valley Road and Wilford Drive.
- (b) At the intersection of Bentrose Drive and Berkley Drive.
- (c) At the intersection of Berkley Drive and Wilford Drive.
- (d) At the intersection of Collin McKinney Parkway and Village Park Drive.

**Sec. 62-347. - Scott Elementary School—Zone designated.**

The Scott Elementary School zone shall be:

- (1) On Eden Drive beginning at a point 110 feet north of Sandy Mountain Drive and extending northward along Eden Drive to a point 280 feet north of Fredericksburg Lane.
- (2) On Millbend Drive beginning at Eden Drive and extending eastward along Millbend Drive to a point 355 feet east of Dripping Springs Lane.
- (3) On Northbound Independence Parkway beginning at a point 300 feet south of Millbend Drive and extending northward along Independence Parkway to a point 140 feet north of Millbend Drive.
- (4) On Southbound Independence Parkway beginning at a point 300 feet north of Millbend Drive and extending southward along Independence Parkway to a point 140 feet south of Millbend Drive.

**Sec. 62-347.1. - Same—Speed.**

The speed limit for the vehicles traveling the streets within the Scott Elementary School zone during the hours of 7:00 a.m. to 8:00 a.m. and 2:50 p.m. to 3:50 p.m., school days, shall be 20 miles per hour maximum.

**Sec. 62-347.2. - Same—Crosswalks.**

Crosswalks shall be established at the Scott Elementary School zone as follows:

- (a) On Eden Drive approximately 120 feet north of the intersection with Millbend Drive.
- (b) At the intersection of Dripping Springs and Millbend Drive.
- (c) At the intersection of Independence Parkway and Millbend Drive.

Section 2. This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, after all the necessary signs and markings have been installed, and it is accordingly so ordained.

Section 3. Any person who violates any provisions of this Ordinance shall be guilty of a misdemeanor and, upon conviction, shall be subject to a fine not to exceed two thousand dollars (\$2000).
