AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS AMENDING THE ONE MCKINNEY 2040 THE ONE McKINNEY 2040 COMPREHENSIVE PLAN: INCLUDING MINOR UPDATES TO THE FUTURE LAND USE PLAN, LAND USE DIAGRAMS, PLACETYPE DEFINITIONS, CRITERIA FOR SPECIFIC USES AND LOCATIONS. THOROUGHFARE **ILLUSTRATIVE** MASTER PLAN, **CROSS-**SECTIONS, UPDATING AND OUTDATED TEXT. **GRAPHICS.** FIGURES, AND THE CORRECTION OF TYPOGRAPHICAL ERRORS; PROVIDING FOR AN EFFECTIVE DATE THEREOF

- WHEREAS, the City of McKinney, Texas, adopted the ONE McKinney 2040 Comprehensive Plan in 2018 to encourage and coordinate future physical development within its Ultimate Planning Area; and
- WHEREAS, an integral part of a successful Comprehensive Plan program is the ability to make periodic refinements in order to keep the Comprehensive Plan up-to-date and calibrated to community changes; and
- WHEREAS, State of Texas Law mandates that all zoning be conducted in conjunction with a Comprehensive Plan; and
- WHEREAS, now in 2020, the City of McKinney desires to make amendments the ONE McKinney 2040 Comprehensive Plan including minor updates to the Future Land Use Plan, land use diagrams, Placetype definitions, criteria for specific uses and locations, Master Thoroughfare Plan, and illustrative cross-sections.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF McKINNEY, TEXAS, THAT:

Section 1. Chapter 3 (Land Use & Development Strategy) of the ONE McKinney 2040 Comprehensive Plan is hereby amended as shown in Exhibit A:
