INTRODUCTION

- The CAPER is a year-end report detailing performance and activities under the CDBG Annual Action plan during the period of October 1 - September 30.
- The City provides the annual action plan at the start of the program year and the CAPER summarize grant performance of the Community Development Block Grant (CDBG) and other community development resources.
- Funds and activities were predominately used to meet the CDBG national objectives of benefiting low-to-moderate income persons and households. The CAPER documents performance and other requirements directed by the U.S. Department of Housing and Community Development (HUD) and local goals of the program by the City.



Regulatory & Statutory Items

- As required, all CDBG activities awarded under the U.S. Department of Housing & Urban Development (HUD) must overall meet the requirement of using at minimum 70% or greater of all funds to benefit low-to- moderate income (LMI) persons.
- McKinney used its funds to impact eligible LMI persons and households. The city did not exceed any statutory cap requirements under grant administration and public service activities.
- No more than 20% of the CDBG allocation can be used for grant administration and no more than 15% can be used for public services. Priorities of program activities are based on community need, city programs and program recommendations under the Community Grants Advisory Commission, a -7-member group of citizen volunteers appointed by City Council.

FY 2019-20 Accomplishments

The Community Development Block Grant is administered by the Housing & Community Development Department and is only one investment resource to improve the quality of life for McKinney residents. The accomplishments are only a small sample of the collective efforts by the city of McKinney

- Increased citizen participation, over 1500 residents participated in housing survey
- Direct CDBG impact to over 600 residents in need
- Sound fiscal responsibility of funding
- Assisted 7 homeowners with repairs
- Outreach partnership with Code Services and Housing & Community Development Department to increase resident awareness of available programs
- Awarded two CDBG-CV grants CARES Act
- McKinney awarded FY 19 HUD grant Rapid-Rehousing, \$306,978 to assist 12 families with housing. (Renewed 2nd yr for 2020-21)
- Increased intergovernmental partnership with Collin County Government and cities
- Provided fair housing, foreclosure tenants rights education to more than 200 residents
- Met CDBG timeliness and fiscal statutory requirements

CONTINUUM OF CARE

Assisting the homeless and providing homeless prevention care

CoC Summary & Accomplishments

The Continuum of Care (CoC) Program is designed to promote communitywide commitment to the goal of ending homelessness; provide funding for efforts by nonprofit providers, and State and local governments to quickly rehouse homeless individuals and families while minimizing the trauma and dislocation caused to homeless individuals, families, and communities by homelessness; promote access to and effect utilization of mainstream programs by homeless individuals and families; and optimize self-sufficiency among individuals and families experiencing homelessness.

McKinney increased support. The Mayor created a Task Force on Homelessness and the city wrote a grant and selected the Samaritan Inn as a partner to develop the McKinney Rapid Re-Housing Program, "designed to connect families experiencing homelessness to permanent housing through a tailored package of assistance that may include the use of time-limited financial assistance and targeted supportive services." The City of McKinney continued to meet participation requirements and support efforts including:

- Participant in the Collin County Homeless Coalition and Metro Dallas Homeless Alliance (MDHA).
- Housing & Community Development Department organizes annual Point-in-Time Count to determine homeless population to receive funding.
- McKinney awarded FY 19 HUD grant Rapid-Rehousing, \$306,978 to assist 12 families with housing. (Renewed 2nd yr for 2020-21)
- Partnership with Public Safety Homeless Liaison and Library Services teams to assist with coordination needs.
- Data participation in Collin County Plan to eradicate homelessness.


