Ms. Best detailed the Consolidated Grants process, an annual application process for agencies, consisting of two grant programs: The Community Development Block Grant (CDBG) and Community Support Grant (CSG). The schedule is based on the review grant process. The next grant cycle will begin February 2021 and a nonmandatory application meeting will be held for interested applicants. Program and technical assistance will be available for support and the deadline for submission is in April. The Community Grants Advisory Commission's role will begin in May, when they conduct public hearings to meet with applicants. The Commissioners will hold their meeting in

approval. The CDBG Action Plan will have a public comment period

before submission to City Council; The CDBG Action Plan must be

submitted to the U.S. Department of Housing and Urban Development

(HUD) no later than August 16 annually for review and final approval.

City Council will conduct a public hearing for CDBG funding in August.

The Community Support Grant is under the General Fund; the City

approves the General Fund in September and the Support Grant

recommendations will be approved in October 2021 August 16th is the

deadline CDBG grants need to be completed.

The City does not yet have confirmation of the allocations to be received

by HUD or City Council to fund the programs. Updates will be provided

at the next meeting.
