JOINT MEETING

JUNE 10, 2021

The Parks, Recreation, and Open Space (PROS) Board and the McKinney Community Development Corporation (MCDC) of the City of McKinney met in joint session at the Senior Recreation Center at 1400 S. College St. McKinney, Texas on Thursday, June 10, 2021 at 5:06 p.m.

21-0483 Executive Director of Development Services Michael Quint presented the Board with an update on development in McKinney. Highlights included the growing population currently estimated at 202,000. He noted that Trinity Falls (MUD) is in the ETJ and does not count towards the City population. He also discussed the growth in commercial and residential property such as the 121 Corridor, new developments along Highway 380, and several residential communities in process. The Development Navigation Assistant (DNA) was designed to provide a step-by-step guide to the permitting process for residential permits. The DNA portal, along with many other resources, are in place to remain transparent and help support customers.

21-0484 Parks Planning & Development Manager Jenny Baker discussed the

Trails Master Plan Update. Responses to the Trails customer survey was positive with 339 responses in favor of features already in the master plan such as connecting all trails, rest stops with shade, a trail locator app, bike repair stations and more. City branding and monuments are in process with the first to be located in Craig Ranch. Dunaway Associates will present the Trails Master Plan Update to the Board in July.

Director of Parks & Recreation Michael Kowski presented the Prospective Projects and Priorities for Funding report. First, he noted that July is Parks & Recreation month. RecQuest, formerly Parks Bingo, an interactive virtual scavenger hunt app with prizes runs all of July. Celebrations throughout July are planned for the openings of newly renovated Senior Center & Pool, Old Settler's Rec Center, as well as newly completed Cottonwood Park. Current goals for Parks & Rec are to refresh, renovate, and finish/connect projects such as Old Settler's Park, the Recreation Center at Towne Lake, Gabe Nesbitt Ballfields, Towne Lake Recreation area, Erwin Park, and the hike & bike trails. The Gray Branch Master Plan is under review currently. Many accomplishments were made such as but not limited to way-finding signage & lighting at the Recreation Center at Towne Lake, Aging Parks master plans for 8 parks, Al Ruschhaupt master plan phase 2, and Finch Park Phase 4. There is currently \$96 million in active projects and of that, \$22 million is MCDC funding and the rest in Park Zones, Bonds, and Grants.
