In fact, I live just on the other side of the gate that was installed to prevent thru traffic. I want to add a comment/concern to the record for the city council to consider as they make a decision. Many of us in Creekview Estates fear continued commercial development into those larger-lot residential areas, and an eventual removal of the traffic gate, which would completely change our day-to-day existence. The opposition letters you get from Creekview Estates residents are likely based on this potential future landscape that could result from this initial zone change being approved.
