## **CITY COUNCIL WORK SESSION**

## **MAY 16, 2023**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, located at 222 N. Tennessee Street, McKinney, Texas on Tuesday, May 16, 2023, at 3:00 p.m.
