# FOUNDATION OF TKI COMMERCIAL SERVICE ASSESSMENT

- North Texas is an outlier among its peers in having only two commercial airports
  - Airlines and passengers agreed
- Airports are economic engines
- TKI already has the runway to accommodate commercial aircraft
- Collin County and North Texas demographics and trends point to success
- Worsening regional surface traffic will only increase drive times to DFW and Love

# TYPICAL WAYS TO FUND AIRPORT CAPACITY PROJECTS

Some combination of

- Federal and State funds
- Bonds backed by
  - General Airport Revenues (GARBs)
  - PFC Revenues

City Tax Revenues (G.O. Bonds)

- Cash reserves on hand
- Airline development
- P3 (public-private partnership) development

  - Implications of the referendum
  - Alternate development options
  - Feasibility of remaining funding options
- 2. Decide decision based on evaluation



#### **Tax Analysis**

- Property Tax
  - Highest ranked collection proposer expected to purchase property in McKinney for permanent facility
  - Existing property and facility/service center expected to remain as taxable property
  - City would not receive taxes from the proposed regional recycling facility
- BPP (Business Personal Property)
  - Highest ranked collection proposer's equipment will be located at permanent facility in McKinney

# Highest Ranked Vendor Highlights Solid Waste Collection - Frontier Waste Solutions

- Headquarters in Dallas, Texas
- 14 facilities from Lake Texoma to the Gulf Coast
- 30 Texas cities including the City of Pearland with 37,000 single family homes
- Significant capital investment to include:
  - Multiple potential properties under consideration for permanent facility in McKinney
  - Purchase all new equipment for McKinney

# Highest Ranked Vendor Highlights Recycling Processing - Balcones Recycling, Inc.

- Headquarters in Austin, Texas
- Built and operate MRFs in Arizona, Florida, Texas
- Finalizing property purchase in Collin County
- 120,000 sq ft MRF will process 190,000 tons annually
- Dedicated lane/acceptance for City vehicles
- Monitored residential recycling drop-off location

#### **Staff Recommendations**

Staff recommends City Council authorize the City Manager to enter into exclusive negotiations with:

- Balcones Recycling, Inc. for recycling processing services
- Frontier Waste Solutions for the collection of solid waste and recycling
