Consider / Discuss / Act on the FY 2023-2024 Funding Allocations for Consolidated Grants Recommendations to City Council.

Commissioners unanimously approved the motion by Vice-Chairperson Lent Keeler, seconded by Commissioner Todd Burton, to approve Consider / Discuss / Act on the Consolidated Grants Funding Recommendations. The Consolidated Grants Application process includes the funding of public service resources to benefit McKinney residents under two grants: Community Support Grant (CSG) and the Community Development Block Grant (CDBG). Applicants applied in April 2023 and presented proposals to the Commissioners in public hearings on May 10, 2023, and May 11, 2023. Administrator Best stated that the Community Grants are funded by the city's General Fund and initial requests must be at least \$3,000; the proposed budget is \$175,00 contingent upon the City Council approval in September, which includes city administered public service programs. Public Service CDBG grants are reimbursable grants, federally funded by the U.S. Department of Housing and Urban Development (HUD) and application requests must be at least \$5,000 for consideration of these funds. Agencies who applied for audit waivers are only eligible for Community Support Grant consideration. The FY24 public service budget under CDBG is estimated at \$144,165 under the City of McKinney. After careful discussion, the CGAC determined their recommendations which required adjustments to balance to the budgeted allocation.

Vice-Chairperson Lent Keeler recused himself at 7:46 so that the board could make recommendations on Journey of Hope. Motion was made by commissioner DeAndre Hinton, seconded by commissioner Todd Burton to approve such recommendations. He returned at 7:50 p.m.
