Mayor Fuller again called for Public Comments at which time there were no additional requests to address the Council.

Mayor Fuller called for Council and Manager Comments.

Council Member La'Shadion Shemwell commented on the deaths by police of African American men George Floyd in Minneapolis, MN, Darius Tarver in Denton, TX, and others, and the resulting protests in numerous cities across the country. Council Member Shemwell commented on a recent racial confrontation in the city. Council Member Shemwell called for the need for action through legislation and innovative ideas to address racism and keep people safe.

Council Member Rick Franklin expressed sympathy for the families of George Floyd and others killed; spoke in support of the right of citizens to peacefully protest and make their point to address issues; and expressed concern for businesses when people choose to loot instead of protest. Council Member Franklin expressed support for the McKinney Police Department to work the right way and called for communities and police to make appropriate change where needed.

Council Member Frederick Franklin congratulated 2020 McKinney High School (MHS) graduate Jakob Shackleton who earned a full scholarship to attend Stanford University. The scholarship is a national ROTC award worth one hundred eighty thousand (\$180,000) dollars. Jakob was a Cadet Battalion Commander with the MHS Marine Corps Junior Reserve Officers Training Corps (JROTC). He will participate in ROTC program at Stanford and enter active duty in the U.S. Marine Corps upon college

graduation. Council Member Frazier commented on the death of George Floyd, wishing the incident would have been handled differently, and called for continued work by police and communities to build together; shared about his work with others to pass bills regarding police dash cams and improved police training.

Council Member Charlie Philips commented on the importance of recycling and encouraged staff and Council members of the meeting to practice recycling.

Council Member Scott Elliott challenged and encouraged everyone to check personal beliefs regarding race, quality policing and social issues affecting communities. Council Member Elliott expressed appreciation for the ability and opportunities for all people to share opinions.

Mayor Pro Tem Rainey Rogers commented on the city Investment Committee earning more than three million dollars in interest over the second quarter of the fiscal year despite stock market challenges during the same period. Mayor Pro Tem Rogers encouraged the public to continue to learn about and apply for business support grants available in the city; acknowledged citizen Tamara Johnson for helping others in need with shopping during the COVID-19 situation; acknowledged the presence of members in the audience for returning to meetings since COVID-19 social distancing measures were put in place. His friend and high school classmate, James Tarver, was among those present. Mayor Pro Tem wished his wife Tammy a happy birthday (June 2).

I am writing to you this morning in response to Regular Agenda Item 20-0456, as published in the Agenda for the upcoming City Council Regular Meeting on Tuesday, June 2, 2020:

"Consider/Discuss/Act on a Resolution Approving the Collin County CARES Emergency Housing and Living Assistance (EHLA-CV) Program Funding for the City of McKinney, from Funding Provided by the U.S. Department of the Treasury"

I currently serve as President of the Board of Directors at Community Lifeline Center (CLC) in McKinney. For more than 30 years, CLC has been providing critical support and services to local individuals and families in crisis, including food, rent, and utility assistance. CLC currently distributes more than 4,000 pounds of food per week through our Lifeline Market Pantry, and we have long-term, well-established relationships with utility providers including CoServ and TXU, who trust CLC to administer their charitable funding dollars to our shared clients who are in dire need of emergency assistance with rent and utilities.

Additionally, CLC works in tight partnership with many other Collin County-based organizations to serve the needs of our community, including formalized relationships with agencies like Wellness Center for Older Adults on the current "Beyond Blue" collaboration that addresses social determinants of health in McKinney ZIP Code 75069, funded by Texas Health Resources. CLC also regularly refers clients to other local agencies such as Allen Community Outreach and Assistance Center of Collin County, and these agencies likewise refer clients to us, so that we may collectively serve our community as efficiently and effectively as possible. CLC is a well-established organization with a stellar reputation for serving our Collin County neighbors in need, when they need it most. Our clients will tell you that CLC cares deeply for them, we understand their needs, and we build great relationships with each other based on mutual respect, dignity, and trust.

In light of CLC's experience and expertise, proven track record of service, and reputation across the community, I was extremely surprised to read the current recommendations for McKinney's portion of EHLA CARES Act funding, which allocates less than 3% of available funding to CLC, the only McKinney-based organization on the list of proposed funding recipients. Additionally surprising was that several of the agencies slated to receive McKinney funding currently have no existing service footprint in the area. CLC may be a small organization on paper, but I am convinced that we absolutely have the best pulse on the immediate needs of our McKinney community, and we are best-positioned to distribute available funding and support in a fair, efficient, effective manner that maximizes positive impact to our local community in a critical time of need.

Therefore, I would respectfully request that the McKinney City Council reconsider the current resolution as written, and consider allocating a greater percentage of available funding to Community Lifeline Center.

Please let me know if I may provide additional information for your consideration. Thank you for your service to the residents of the City of McKinney, and thank you for doing what's best for our greater community during the current pandemic environment.

On behalf of the Members of the Visit McKinney Board of Directors, we would like to express our support for the City of McKinney's updating of its alcohol consumption ordinance to allow visitors and residents to consume glasses of wine, beer, and other spirits outside of some currently restricted areas of the city when purchased from properly-licensed vendors. Such a change would bring McKinney's ordinance into closer alignment with TABC 109.35 which states that public consumption in open containers is legal throughout Texas.

Typically a vendor or business with a TABC license would need a specific permit for offsite consumption. As of today, thanks to implementation of the recent directive from Governor Abbott, licensed vendors have the ability to sell alcohol "to go." In addition, McKinney's City Ordinance's Chapter 14, Article 2, allows for alcohol consumption at special events and in locations including recreation centers, the McKinney Performing Arts Center, McKinney National Airport, private clubs, and closed-off restaurant sidewalk patios.

Extending coverage of the public consumption ordinance to include the entire city's entertainment districts including the Downtown Cultural District, Adriatica, Hub 121, and future such areas would align our city with other visitor-friendly cities, too. Texas cities including Georgetown, Fredericksburg, and Galveston, all of which are very visitor-friendly cities, currently allow for open containers. Public consumption ordinances such as what we would support in McKinney are in place in other tourism-friendly parts of the country as well, including:

□ Savannah, Georgia's historic district;
□ multiple entertainment districts in Huntsville, Alabama;
□ The Power & Light District in Kansas City, Missouri;
□ Memphis, Tennessee's Beale Street District; and
☐ Gulfport. Mississippi's waterfront entertainment district, to name a few.

Updating this ordinance would not encourage a free-for-all "party scene" as other city laws would curb negative behavior such as disorderly conduct, DUIs, minor in possession and such. Other restrictions including the size and material (plastic versus glass) of the allowed containers could be specified in the updated ordinance in the interest of better control.

Allowing open containers gives a city a much more visitor-friendly atmosphere, allowing guests to explore an entertainment district within our city while enjoying its sights and sounds. In addition, in light of McKinney's recent designation as a Music Friendly Community by the Texas Music Office of the Office of the Governor, this would allow guests to more fully enjoy live music throughout the city's entertainment areas.

We on the Visit McKinney board fully support a change to the City of McKinney's open container public consumption restrictions in order to encourage the greater enjoyment of our entertainment districts and to encourage the future development of such areas and to support overall future economic development. In addition to providing a more visitor-friendly image to leisure travelers and residents, this change would also make the city more attractive to groups and companies wishing to bring meetings and events to McKinney, to stay in our hotels while here for multiple days, and even to settle their businesses and families here permanently, producing an increase in positive economic impact for the city as a whole.

We applaud the efforts the City Council and City leadership has taken to help all residents, businesses and non-profits during a global pandemic impacting many aspects of our lives. As businesses are looking to adapt services, add new lines of service and be able to re-coop revenue losses during the necessary shut-down for health purposes, we are advocating to help one of the hardest hit industries – restaurants.
