## **CITY COUNCIL WORK SESSION**

## **JANUARY 19, 2021**

The City Council of the City of McKinney, Texas met in work session in the City Hall Council Chambers, 222 N. Tennessee Street, McKinney, Texas on Tuesday, January 19, 2021 at 3 p.m.
