Cottonwood Park is almost complete & residents are excited to start

enjoying the new amenities. The signage & lighting at the Recreation Center at Towne Lake is almost done. The next improvement phase will include an arts commission for a mural along the exterior wall of the center. Erwin Park is getting upgrades; new pavilions, restrooms with showers, parking, renovated campsites and more. Parks Maintenance fabricated another set of UNIQUE letters to showcase at the AT&T Byron Nelson PGA Tournament.
