I think it would be widely appreciated to see an employee parking permit option made available for lots on the South side of the Square. While there are multiple lots on the North side of town, it is intimidating for women to walk alone at night and into darkened parking garages. Having an employee parking option that offers south side access is still greatly needed - especially if Lot 4 is turned into 3-hour parking. MANY employees park there currently because it is well lit, close to people, and feels safe. The same reasons that make patrons desire the location, are also needed to ensure the security and safety of our wonderful downtown employees.

I am writing to you to let you know that I am opposed to the zoning changes to the land at the Northeast corner of Wilmeth Rd. and Community Blvd. 20-014126 By adding multi-family residential units it will bring more traffic to an already congested area. While most of Community Blvd is already 4 lanes, just past McKinney North High School and Scott Johnson Middle School, to Avalon Creek Way, Community Blvd is only two lanes We have two entrance/exit on Community Blvd. One at Brinlee Branch Lane and the other at Avalon Creek Way. When school is in session, instead of going down Community Blvd. to get to the school(s) the parents and High School students of McKinney North High School have discovered that they can cut through the neighborhoods of Timber Creek and Creek Hollow. During the time that students are going to school the traffic becomes so backed up on Brinlee Branch that residents that live on Willow Creek Trail, Trickling Creek Lane, Bluff Creek Lane can not make a left hand turn on to Brinlee Branch Lane due to the steady stream of traffic. I have been told by city staff that there are no current plans to widen Community Blvd between Brinlee Branch Lane and Avalon Creek Way. Currently, the bridge on Bloomdale is being constructed. When the bridge is finished there are plans to build commerical buildings, which will add more traffic coming down Community Blvd making it even more difficult for residents to get out of the neigborhood.
