I reside in The Estates at Craig Ranch and strongly oppose the Crave Ghost Kitchen proposed at Piper Glen and Collin McKinney. This start-up venture has reportedly been unresponsive to City Council Members and residents indicating they have no intention of being a good neighbor or how they will respond to future Code/Health/Life/Safety issues.

I managed DFW corporate headquarter sites (which included cafeterias) for 30 years and was heavily involved in all aspects of Food Services. Third-party industry experts with global presences operated the cafeterias. I am familiar with challenges such as emissions/air pollution, cleanliness,

rodent/gnat/fruit fly infestations, proper food temperatures, health inspections, numerous deliveries, etc. Scheduled grease trap and vent hood cleaning is mandatory and performed after hours due to strong odors, emissions/air pollution and noise from the pump trucks. This, along with the steady flow of food/supply, trash/recycle bin vehicles and a fleet of delivery drivers will negatively impact residents in The Estates and the Artistry and present potential Life/Safety risks to future Byron Nelson participants and spectators for the next 4 years as well as multiple events held by Craig Ranch Fitness events.
