Main Street / MPAC, Visit McKinney Finance Committee

<u>City of McKinney</u> – City Manager Paul Grimes updated on the progress of the new development code for the City of McKinney, the council boundary redistricting process triggered by the completed census, the special election for the City's At Large 2 seat, that is required to be held since Council Member Frederick Frazier has announced he will be running for state representative in Texas House District 61. City Council Liaisons Richard Franklin and Justin Beller had nothing to add.

MEDC – MEDC Manager of Business, Retention and Expansion Madison Clark highlighted the Raytheon expansion, the Independent Financials' nomination as one of the finalists for Dallas Business Journal-2021 Best Real Estate Deal in HQ/Campus Category, and the results of a recent Click Ad Campaign.

<u>MCDC</u> – MCDC Board Liaison Rick Glew gave an overview of the timing and dollar amounts for the current grant cycle, reported on the status and stood for questions regarding the TUPPS Brewery Expansion Project.

McKinney Main Street / MPAC – McKinney Performing Arts Center/Main Street

Program Director Amy Rosenthal listed upcoming holiday events for November and

December with a special focus on the Menorah Lighting, a new to downtown McKinney

event taking place on November 30, 2021.

Visit McKinney Finance Committee – Board member Jon Dell'Antonia covered the operating statement of September 2021, which closes out the fiscal year 2020/2021, highlighting the good financial decisions this year and the exceptional occupancy rate of 100 percent for the Hampton Inn. Dell'Antonia went through the STR report with the Occupancy, Average Daily Rate (ADR), and Revenue per Available Room numbers (RevPAR), comparing the numbers with the surrounding cities, and addressed the number of RFPs that cannot be met due to the lack of adequately sized facilities.
