### Electioneering

**Electioneering** is specific to political activity on city-owned property when such property serves as a voting location

★ McKinney Code of Ordinances,Chapter 38, Article IV – Electioneering

**Non-city voting locations** may have separate, different rules for political signs and activities



# Appendix A – #22-0745 Presentation 2/3 **Electioneering**

- Activity and signs allowed at 24 hours before until 24 hours after voting period
- 100' "electioneering-free" zone
- Sign dimensions limited to 2' x 2'
- Driveways restricted
- Restrictions for certain structures and megaphones
- Fire Chief may determine unsafe areas



Administered and enforced by City Secretary, Code Enforcement and Law Enforcement



# **Political Signs**

(Non-Electioneering) Political signs must comply with city regulations

McKinney Code of Ordinances,Chapter 134 - Signs

## Electioneering

- Signs in the right of way (ROW) that impose a hazard are removed immediately
- Candidates provided 24 hour courtesy call or email to remove non hazardous signs
- Section 134-4 (c) allows signs to be disposed of with no notice
- Impounded signs are held for five days as a courtesy
- 525 signs were impounded during the last election

Staff requests City Council feedback on giving 48 hours notice on all impounded signs before they are discarded
