**ITEM SUMMARY:**

- This Resolution authorizes award of a fixed price contract with TRIARC Systems, LLC of Mansfield, Texas for Rifles for McKinney Police Department

**BACKGROUND INFORMATION:**

- The purpose of this contract is to provide the Police Department with the ability to obtain rifles under a fixed price contract on an as needed basis.
- The City issued Invitation to Bid 23-04FP, Rifles For McKinney Police Department on October 30, 2022.
  - Advertised in McKinney Courier Gazette

- Posted on McKinney TV
- 138 matching eBid Supplier Notifications which included eight (8) Historically Underutilized Business (HUB) suppliers.
- Out of 138 supplier notifications, four (4) bids were received on December 1, 2022, from the following suppliers:
  - TRIARC Systems, LLC
  - Caracal USA, LLC
  - IWI US Inc
  - Proforce Marketing, Inc.
- An evaluation team comprised of City staff reviewed and ranked the bids based on the following criteria:
  - 40 Points - Purchase Price
  - 25 Points - Extent to Which Submission Matches Specifications
  - 20 Points - Delivery Schedule
  - 10 Points - Vendor's Trade In Program
  - 5 Points - Reference Check
- The evaluation team recommends TRIARC Systems, LLC as the best value for the city.
- Contract will commence on date of award and continue for one (1) year period with additional two (2) one-year terms.
