**ITEM SUMMARY:**

- This Ordinance amends the Fiscal Year 2023-2024 Annual Budget and the 2024-2028 Capital Improvements Program by increasing the funding from the Texas Department of Transportation by \$29,923 from \$6,400,000 to \$6,429,923 and appropriating this increase in the Capital Improvement Program Project AI2114, Taxilane A Realignment & Rehabilitation.
- This Ordinance amends the Fiscal Year 2023-2024 Annual Budget and the 2024-2028 Capital Improvements Program by increasing the allocation of the IIJA funds administered by the Texas

Department of Transportation by \$600,017 from \$1,607,000 to \$2,207,017 and appropriating this increase in the Capital Improvement Program Project AI2114, Taxilane A Realignment & Rehabilitation.

**BACKGROUND INFORMATION:**

- The proposed scope of work for Phase I will consist primarily of:
  - The removal of Taxiway B3
  - The construction of Taxiway A3
  - The relocation of Taxilane A's centerline 68 feet to the east
  - The construction of additional aircraft parking apron
  
- The removal of Taxiway B3 and the construction of Taxiway A3 will address the safety issue of direct connection from the apron to the runway identified by the FAA.
  
- The relocation of Taxilane A's centerline to the east will allow for additional aircraft parking apron between the fire lane and the Taxilane A Object Free Area.

**FINANCIAL SUMMARY:**

- This Ordinance amends the Fiscal Year 2023-2024 Annual Budget and the 2024-2028 Capital Improvements Program by increasing the funding from the Texas Department of Transportation by \$29,923 from \$6,400,000 to \$6,429,923 and appropriating this increase in the Capital Improvement Program Project AI2114, Taxilane A Realignment & Rehabilitation.
  
- This Ordinance amends the Fiscal Year 2023-2024 Annual Budget and the 2024-2028 Capital Improvements Program by increasing the allocation of the IIJA funds administered by the Texas Department of Transportation by \$600,017 from \$1,607,000 to \$2,207,017 and appropriating this increase in the Capital Improvement Program Project AI2114, Taxilane A Realignment & Rehabilitation.
  
- Total Phase I Project costs are estimated not to exceed \$9,596,900. The City of McKinney will be responsible for the 10% match of \$959,690.
