#### **ITEM SUMMARY:**

 This Resolution authorizes award of a contract with InVeris Training Solutions, Inc. of Suwanee, Georgia for the purchase of a virtual reality police training simulator.

#### **BACKGROUND INFORMATION:**

- The City issued Request for Proposals (23-36RFP) for a Virtual Reality Police Training Simulator on June 18, 2023, on behalf of the Police Department after receiving the 2022 Urban Area Security Initiative (UASI) Federal Grant for \$125,000.
  - o Advertised in McKinney Courier Gazette
  - Posted on McKinney TV
  - o 260 matching eBid Supplier Notifications which included seventeen (17) Historically

Underutilized Business (HUB) suppliers.

- Out of 260 supplier notifications, one (1) bid was received on July 6, 2023, from InVeris
  Training Solutions, Inc. of Suwanee, Georgia.
- An evaluation team comprised of staff from the Police Department reviewed and ranked the bid based on the following criteria:
  - o 35 Points Proposed Pricing
  - 35 Points User Experience
  - o 20 Points Project Timeline and Implementation Plan
  - o 10 Points Respondent's Background
- Based on the results of the evaluated proposal, the evaluation team has recommended the award of the contract go to InVeris Training Solutions, Inc. of Suwanee, Georgia.
- Contract, not to exceed \$125,300.00 for the total price as outlined in the proposal.
