ITEM SUMMARY:

- This Ordinance amends the Fiscal Year 2023 - 2024 Annual Budget to provide funding for the purchase of trash and recycling carts and to provide public education.
- The necessary funding will come from the Solid Waste Fund balance and reimbursement from a grant received from The Recycling Partnership.

BACKGROUND INFORMATION:

- The City issued solicitation (23-11RFP) Solid Waste & Recycling Collection and Recycling

Processing Services on December 11, 2022.

- The City requested pricing in the RFP for the purchase of 95-gallon carts on behalf of the City.
- The City Council authorized a contract with Frontier Waste Solutions on August 15, 2023, which included the purchase of 95-gallon carts with the City retaining ownership.
- The City will purchase new trash and recycling carts for the new franchise agreement for solid waste collection with Frontier Waste.
- The City will retain ownership of 131,879 residential and commercial trash and recycling carts.
- Grant funding from The Recycling Partnership will reimburse \$15 per residential recycling cart for the carts purchase with a funding cap of \$870,000, and \$2 per household for public education for a total combined amount of \$986,000. No funding match is required for this grant.

FINANCIAL SUMMARY:

- This Ordinance amends the Fiscal Year 2023 - 2024 Annual Budget to provide funding for the purchase of trash and recycling carts and to provide public education.
- The total amount of the amendment in the Solid Waste Fund will be for \$7,096,718:
 - \$3,659,448 for trash carts
 - \$3,321,270 for recycling carts
 - \$116,000 for public education
- The City will receive grant reimbursement of \$870,000 (\$15 per cart based on 58,000 carts) for residential recycling carts purchase and \$116,000 (\$2 per household based on 58,000 households) for public education from The Recycling Partnership for a total amount of \$986,000. No funding match is required for this grant.
