- **Method of voting:** to be used in the runoff election on Election Day, Saturday, June 5, 2021, Early Voting in Person, Early Voting by Mail, and Provisional Voting, be the ExpressVote Universal Voting System, EVS 6.0.2.0 consisting of Electionware election management software, ExpressVote ballot marking device, ExpressTouch curbside voting device, DS200 precinct tabulator/scanner, DS450 high speed central scanner, and DS850 high speed central scanner, in accordance with the Texas Election Code.
- **Canvass date and time:** not earlier than Tuesday, June 8, 2021 and not later than Wednesday, June 16, 2021; Notice of canvass will be posted at least 72 hours prior to the event, in accordance with Texas Government Code.
- Appointment of Bruce Sherbet, Collin County Elections Administrator, as the Early Voting Clerk for the purpose of conducting early voting.

FINANCIAL SUMMARY: The cost for the Run-Off Election will be approximately \$30,000 and will be paid out of contingency funds.
