- Interviews will be conducted in July / August (schedule to be determined)
- Prior to October 1, new and reappointed members must complete Board Member Orientation conducted by the Board and / or Office of the City Secretary (schedule to be determined)

- Every year, approximately half of all McKinney Boards & Commissions appointments expire, with those vacancies filled by City Council vote.
