BACKGROUND INFORMATION:

- This work will set forth how we establish fees and charges in relation to various goals, market conditions, benchmarking, demand, cost recovery targets, and industry trends.
- A primary component of this project includes a comprehensive cost of service analysis using a
 proprietary online-based Cost Recovery Module, which is designed to accelerate the data
 collection and sorting functions that are necessary tasks associated with a cost of service
 analysis.
- This will promote maximum resident participation in our parks system, potentially reduce our reliance on subsidies from the general fund and ensure that no one has a barrier to participation.
- Deliverables include a Cost Recovery Model and Financial Management Philosophy report, as well as access to the proprietary online-based Cost Recovery Module.
