#### **ITEM SUMMARY:**

• This Resolution authorizes a contract with Alliance Geotechnical Group to provide materials testing services during the construction of Collin McKinney Parkway (Lake Forest Drive to Tina Drive) Project (ST1841), for an amount not to exceed \$130,000.

#### **BACKGROUND INFORMATION:**

- A concurrent item is included on the Council Agenda recommending award of a construction contract for the Collin McKinney Parkway (Lake Forest Drive to Tina Drive) Project (ST1841).
- Material testing services will be required on the project to ensure construction materials used by the contractor meet or exceed City requirements.
- Alliance Geotechnical Group, Inc. submitted a response to RFQ 21-18 for miscellaneous geotechnical and materials testing services. They were one of five firms shortlisted by City Council on March 16, 2021.
- Alliance Geotechnical Group, Inc. has successfully performed in a similar capacity on numerous City projects.
- Alliance Geotechnical Group, Inc. has submitted a proposal for their professional services in the amount of \$110,305.00.
- Reimbursement for materials testing services provided will be made based on actual time and materials billing in an amount not to exceed the estimated proposal amount.
- There is an accompanying item on the Council Agenda authorizing a Construction contract for the project.

## FINANCIAL SUMMARY:

- The Resolution authorizes a contract with Alliance Geotechnical Group for an amount not to exceed \$130,000.
- With approval of this item and accompanying items for the Collin McKinney Parkway (Lake Forest Drive to Tina Drive) Project, \$330,324.78 will remain in Project ST1841.
