**RECOMMENDED CITY COUNCIL ACTION:**

- Staff recommends approval of the proposed right-of-way abandonment.

**ITEM SUMMARY:**

- Staff received a request to abandon a portion of an unnamed alley located on the south of Louisiana Street and north of Cloyd Street, approximately 100 feet east of Chestnut Street.
- The right-of-way consists of an area 20 feet wide extending from Louisiana Street to 97 feet south, and containing approximately 0.0444 acres.
- A variable width Access, Utility, & Drainage Easement is retained by the City of McKinney over

the entirety of the vacated right-of-way.

- Public hearing notices were sent to all property owners within 200 feet of the requested abandonment, and a legal notice was published in the McKinney Courier-Gazette. As of November 16, 2022, staff has received no comments in support of or opposition to this request.
- All owners adjacent to the right-of-way have signed a petition supporting the requested abandonment.
