- The deadline to apply is Friday June 16, 2023. Apply online at
 https://mckinney.granicus.com/boards/apply. Incumbent board members should use the email address on file to update their existing application.
- Interviews will be conducted in July / August, and all approved candidates will be contacted to confirm their schedule.
- Prior to October 1, new and reappointed members must complete Open Government Training and any related training as assigned.
- City Staff promote Boards & Commissions participation by providing information online and through social media, publishing and distributing print materials, presenting information at board meetings and community events. - Every year, approximately half of all McKinney Boards & Commissions appointments expire, with those vacancies filled by City Council vote.
- Appointment terms last two years. Board Members can serve up to two (2) or three (3) consecutive terms, depending on their respective board.
