### RECOMMENDED CITY COUNCIL ACTION:

Approval of the Resolution.

#### ITEM SUMMARY:

- This Resolution establishes the times for the reduced speed school zones at Faubion Middle School for the 2025 summer school sessions.
- McKinney Independent School District will hold in-person summer school at Faubion Middle School within McKinney.
- The summer session at Faubion Middle School will begin June 2, 2025, and will end June 20, 2024. School will be in session from 8:00 am to 3:00 pm for elementary school and 8:30 am to 12:30pm for secondary school Monday through Friday.
- For arrival, the reduced speed school zone will be effective beginning 30 minutes before the beginning of the elementary summer session for the day and end 15 minutes after the beginning of middle school. For dismissal, the reduced speed school zone will be effective 15 minutes before the dismissal of each summer session and will end 45 minutes after dismissal of school. The active times for the summer school speed zones are consistent with the

durations used during the regular school year.

## **BACKGROUND INFORMATION:**

- In 2003, the City Council adopted an Ordinance that provides a process to establish a reduced speed school zone for summer school sessions.
- The process involves the City Council adopting a Resolution that designates the school and times of the summer school sessions.
- This item has been prepared in accordance with the established process.
- The reduced speed school zone limits to be active during summer school sessions remain as defined in Chapter 62, Article V. of the City of McKinney Code of Ordinances.

#### FINANCIAL SUMMARY:

• Funding for the signage necessary to establish the reduced speed school zones for the schools holding summer school in 2025 is in the Engineering operating budget.
