- An evaluation team comprised of City staff, reviewed and ranked the bids based on the following criteria:
 - o 40 Points Purchase Price

 - 20 Points Reputation of the Bidder and of the Bidder's Goods or Services Verified through Reference Checks
- The evaluation team recommends The Goodyear Tire & Rubber Company as the best value for the City.
- Contract shall commence on date of award and continue for a two (2) year period.
